CALLS TO ACTION

1. **Register to Vote:** VoteAmerica provides a customized voter registration portal that can be integrated into various ways to increase voter engagement efforts. <https://www.voteamerica.com/register-to-vote/>
2. **Verify Your Registration Status:** Make sure you are still registered, as some voters' names have been purged from the voter rolls. Local election offices purge their voter registration lists. They delete people who have moved or haven't voted for a long time, and many times are done by error. That's why it's a good idea to verify your registration status now even if you have voted in the past. Take a quick 10 seconds to confirm your voter registration status. <https://www.voteamerica.com/am-i-registered-to-vote/>
3. **Request Mail-In/Absentee Ballot:** In a timely fashion, properly complete and send in your absentee ballot application and then submit your absentee ballot before the deadline. Be aware of and meet all deadlines for the absentee application and the absentee ballot itself. Contact your local election office if you need assistance. <https://www.voteamerica.com/absentee-ballot/>
4. **Make a Voting Plan:** Plan how and when you're going to vote and make sure you're fully prepared to do so. Some questions you'll have to answer: Where are you voting? Are you going to the polls or do you have a mail-in ballot? How are you getting to your polling place? Do you need to take off work? Do I have a proper ID?

STRATEGIES TO MOBILIZE YOUR COMMUNITY

Educate Your Organization on Basic Voting Facts: Learn what your members need to vote (e.g., ID, polling locations, candidates' positions on issues impacting your community; special issues like restoring voting rights, veterans & student voting instructions, early and absentee voting; sample ballot). <https://www.voteamerica.com/legal-changes/>

Know Your Rights: Understand what your organization can legally do in elections. For comprehensive information on exercising voting rights, resisting voter intimidation and disability accommodations, requesting a provisional ballot if your name is not on the voter rolls, check out the ACLU's guide by clicking the link. <https://www.aclu.org/know-your-rights/voting-rights/>

Timing: Focus efforts on the last 3 weeks before the election. Increase efforts in the final week and day before Election Day. If your state uses all vote-by-mail, start intensifying your efforts a little earlier. <https://www.voteamerica.com/vote-by-mail/>

Promote Early Voting Opportunities: Early voting can allow voters to avoid lines and provides additional flexibility in casting a ballot prior to Election Day. <https://www.voteamerica.com/early-voting-calendar/>

Tie Your Mission to the Election: Help voters understand the connection between voting and the services you provide. Give your community a reason to go to the polls.

Mobilize Staff and Volunteers: Educate staff and volunteers about how and when to vote and involve them in get-out-the-vote activities.

Educate Voters on the Voting Process. Simplify the voting process by helping voters determine where, when, and how to vote. Look up polling locations and educate new voters on what will happen at the polls. <https://www.voteamerica.com/>

Encourage and Remind People to Vote. Incorporate voting reminders into services and programs in the weeks leading up to Election Day. Make the election highly visible in your communications and at your agency. <https://www.voteamerica.com/election-reminders/>

Plan an Election Day Celebration. Create a celebratory atmosphere on November 3rd and continue to remind people to vote! <https://www.voteamerica.com/where-is-my-polling-place/>

SAMPLE VOTING MESSAGES

ELECTION DAY

*As you know, we have a critical election upcoming. And this Election Day on Tuesday, November 3rd may be the most critical election of our lifetimes. Go to **VoteAmerica.com** to find your polling place today.*

MAKE A VOTING PLAN

*In the midst of a pandemic, when voting will be made more difficult due to fewer polling locations and the need to socially distance, having a plan to vote is more important than ever. Go to **VoteAmerica.com** to find the information and resources you need to vote.*

CHECK YOUR REGISTRATION STATUS

*The most important thing you can do right now is **CHECK YOUR VOTER REGISTRATION STATUS**. If you are not registered - register now. You can do both at **VoteAmerica.com***

VOTE BY MAIL OR ABSENTEE BALLOT

There's a lot of talk right now about voting by mail. And while some may be hesitant to mail in your ballot, I want you to have all the information should you choose to vote by mail.

First off, it's safe and secure. And it's pretty simple:

- **Request** your mail-in ballot online at VoteAmerica.com
- When you **receive** your ballot by mail, fill it out as soon as possible
- Then **return** your ballot by mail

And to make sure your ballot counts when you return it:

- Sign the **outside of the return envelope** - don't sign the actual ballot (your vote is private)
- Make sure your signature on the envelope matches the signature on your driver's license
- Mail your ballot back **EARLY** - Ballots **MUST** be received by Election Day - Nov. 3rd
- And if you don't want to mail in your ballot, you can drop it off in person - VoteAmerica.com can tell you where you can drop off your ballot

EARLY VOTING

*If you want to **vote in person**, **VOTE EARLY**. Find out early voting dates on **VoteAmerica.com**. Most states offer early voting starting October 15 and National Vote Early Day is October 24.*

Early Voting

Did you know that you can vote early in 41 STATES and the DISTRICT OF COLUMBIA?

That means you get to avoid Election Day Lines and VOTE when it's convenient for you.
